LIABILITY WAIVER / CONCUSSION POLICY (ADULT/MASTERS)**

In consideration for the permission granted by the Pasadena Japanese Athletic Association, a California corporation; the Pasadena Bruins Basketball organization; and the Pasadena Japanese Cultural Institute, a California corporation; (hereinafter collectively the "Pasadena Organizations"), I undersigned parent/legal guardian of the player(s) herein listed, for themselves and their minor child participant(s), hereby voluntarily release, waive and discharge the Pasadena Organizations, their officers, directors, employees, representatives, affiliated organizations and agents from any and all liability, arising out of or in connection with my involvement and my minor child's participation in the Bruins Crown City Classic Invitational Basketball Tournament (hereinafter the "Tournament"). For the purposes of this agreement, liability means all claims, demands, losses, causes of action, suits, or judgments of any and every kind arising out of all personal injuries, death, illness, property loss or damages to property of any nature incurred while participating in the Tournament. I, the team representative, by my execution of this agreement hereby acknowledge that our team is responsible for providing its own medical insurance for the players listed on this form and herein agree, on behalf of our team to hold harmless, defend and indemnify the Pasadena Organizations from all liability, as defined, resulting from or in any manner arising out of our players participation in the Tournament. **Photo Release:** I hereby grant the Pasadena Bruins the right and permission to use and publish the photographs made of me by the Pasadena Bruins Organization. I hereby release the Pasadena Bruins organization from all liability from such use and publication. Additionally, I hereby authorize the reproduction for use on the Pasadena Bruins website and waive any right to royalties or other compensation arising or related to the use of my image. The Pasadena Japanese Athletic Association (PJAA) may use photographs of children taken during our tournament which may get posted on the Pasadena Bruins website.

Concussion policy:

- If any coach, game official or division coordinator observes any player to exhibit concussion symptoms, or hears a player complain of concussion symptoms, that player will be removed from the game and will not be permitted to return to that game.
- All scoresheets for the player's team's remaining games shall be marked to highlight the player's name noting that he or she was removed from a prior game for suspected concussion.
- The player will not be permitted to play in any further Tournament games (for this year) until evaluated and cleared by a licensed health care provider, and written clearance from such health care provider is presented to the division coordinator.
- No game or division coordinator will permit a player that has been removed from a game with concussion symptoms to enter a subsequent tournament game without having received confirmation from the division coordinator that the player has received medical clearance to play.
